

# **& ALLIED HEALTH BILLING**

We are mixed billing practice and appreciate full payment of fees on the day of consultation, fees are payable by EFTPOS.

#### PLEASE NOTE: Dr El does not bulk bill.

Patients who have a Medicare card can obtain their rebate directly into their bank account via your EFTPOS card at the time of payment. Please note: If paying by credit card a direct rebate can only be done to a savings/cheque account so we can send the request to Medicare and it will be paid into your nominated bank account within 2 business days if you have your bank details registered with them.

Patients under a TCA are charged at the full rate (no concessions) with Medicare providing a rebate.
